

## ST VIRTUAL RUN 2020 GRAND LUCKY DRAW TERMS AND CONDITIONS

1. By registering or taking part in the ST Virtual Run 2020 Grand Lucky Draw (the "Lucky Draw"), all participants agree to be bound by and to comply with the Lucky Draw Terms and Conditions ("these T&Cs") as set out herein, including all amendments, additions, replacements and modifications hereto as may from time to time be made by SPH.
2. Non-compliance with or breach of any of these T&Cs may disqualify a participant from the Lucky Draw, and any prizes won may be forfeited, withheld, withdrawn or reclaimed in SPH's sole and absolute discretion without compensation to the participant.
3. The Lucky Draw is only open to individuals (i.e. Singaporeans, Permanent Residents, Employment Pass Holders and Dependent Pass Holders) residing in Singapore who have signed up to take part in the ST Virtual Run 2020 ("STVR 2020") and who satisfy all the conditions in these T&Cs (collectively, "Participants"; each a "Participant").
4. Employees of SPH and its related corporations ("SPH Group") or of SPH's partners and/or sponsors for the Lucky Draw, and their immediate family members (including spouses, children, parents, brothers and sisters) are not eligible to participate in the Lucky Draw.
5. Those taking part in the STVR 2020 via complimentary access will also not be eligible to enter the Lucky Draw.
6. Participants will need to complete their registered STVR category (17.5km/175km) in order to be eligible to enter the Lucky Draw. Winners of the Lucky Draw will be selected from the eligible participants. No separate entry or application form for the Lucky Draw will need to be submitted.
7. Participants affirm that all details and particulars submitted to SPH are true, accurate and complete. Any incorrect or incomplete information found will result in the participant's disqualification and/or the forfeiture, withholding, withdrawal or reclaiming of any prizes won.
8. The Lucky Draw will be conducted electronically on November 2, 2020 at SPH News Centre and the results will be announced on the STVR 2020 website ([www.straitstimesrun.com](http://www.straitstimesrun.com)) or through other channels as may be determined by SPH.
9. Winners will be notified by **November 9, 2020** via SMS and/or email based on the submitted registration details. If a winner cannot be contacted for any reason whatsoever, SPH shall at its sole and absolute discretion elect to determine another winner in accordance with the Lucky Draw mechanism.
10. Prizes won are not transferable, or exchangeable or redeemable for cash. Winners are responsible for collecting any prizes won **in person**. Winners will be advised of the date(s), time(s) and venue(s) for the collection of prizes separately.
11. Prizes are subject to availability and where applicable, certain prize winnings may be further subject to the rules or restraints by governments or public authorities, health warnings, advisories or other directives issued by any governments or governmental agencies. SPH may (but is not obliged to) substitute any prize for a comparable prize of equal or greater value to be awarded in lieu.
12. Winners acknowledge that neither SPH nor the sponsors accept any responsibility for any taxes, costs, expenses and other liabilities that may arise from the prize winnings, which shall be the sole responsibility of the winners upon claiming such prize winnings.

13. SPH reserves the right at any time in its sole and absolute discretion to:
  - (a) cancel or modify the Lucky Draw; or
  - (b) vary, substitute, withdraw or cancel any prize without prior notice and without having to disclose any reason therefore and without any payment or compensation whatsoever.
14. Winners must present the NRIC/ Work Pass for verification during the collection of prizes.
15. Winners may be required to sign a written statement confirming their eligibility before prize collection. All winners may be required to attend a prize presentation ceremony.
16. By participating in the Lucky Draw, each participant agrees and consents to:
  - (a) the terms of our Privacy Policy which can be found at [http://sph.com.sg/legal/sph\\_privacy.html](http://sph.com.sg/legal/sph_privacy.html) as amended from time to time, and the terms of the Privacy Policy are incorporated into these T&Cs by reference;
  - (b) SPH Group and the Lucky Draw sponsor(s), as well as their respective representatives, agents or authorised service providers, collecting, using and disclosing the participant's personal data and sharing the participant's personal data between themselves and their business parties to communicate with the participant for purposes related to the Lucky Draw, to provide goods and services to the participant upon request, to send the participant marketing information on products and services offered by the SPH Group or other parties, and for such purposes that the participant has otherwise given his/her consent to SPH Group;
  - (c) SPH Group, as well as their respective representatives, agents or authorised service providers, collecting, using, disclosing and processing the participant's personal data, and sharing between themselves and their business partners, the participant's personal data, including the photographs or audio-video or other recordings of these participants ("Material") for publicity and/or use in advertisements across all media, including, without limitation, in SPH Group's publications, presentations, promotional materials on their websites and social media, in its original or edited format, and whether to promote the Lucky Draw or otherwise without further notification, remuneration or compensation; and
  - (d) the copyright and all other intellectual property rights in and to all Material shall vest solely and absolutely in SPH without further compensation, and to the maximum extent permissible under law, each participant hereby waives its moral rights comprised in and to all Material in favour of SPH.
17. Participants shall not, without the prior written approval of SPH, speak to the press or any other media nor give any interviews or comments relating to the Lucky Draw.
18. SPH Group shall not be liable for any loss (including, without limitation, indirect or consequential loss), damage, personal injury or death in connection with the Lucky Draw, or any prize, except any liability that cannot be excluded by law (in which case that liability is limited to the minimum allowable by law). All warranty claims in regards to a prize should be directed to the applicable manufacturer. Except to the extent that they may not be excluded by law, no representations, warranties, terms or conditions that are not expressly stated in these T&Cs apply to the Lucky Draw nor in respect of the prizes and all implied warranties are excluded, including but not limited to, the implied warranties of satisfactory quality, merchantability or fitness for a particular purpose of any of the prizes.

19. Prizes not claimed after the redemption date(s) stated in the announcement or notification sent by SPH will be forfeited and dealt with by SPH in its sole and absolute discretion, according to applicable law.
20. SPH's decision on all matters relating to the Lucky Draw will be final, binding and conclusive on all participants, and no correspondence will be entertained.
